 Registered Apprenticeship (RA)



Background

Started small, and planned for growth...

- 2017-18: 5 students, 1 business
- 2018-19: 24 students, 8 businesses
- 2019-20: 28 students, 10 businesses – SALEM Added
- 2020-21: 15 students, 9 businesses (COVID)
- 2021-22: 22 students, 10 businesses – ROANOKE CITY Added
- 2022-23: 37 students, 14 businesses
- 2023-24: 47 students, 18 businesses





- Provide Intensive HQ YRA/RA Opportunities
- Meet Local B&I Workforce Development Needs
- Collaborate to Provide a Single Source of Information

Why Do We Collaborate?

To provide a large pool of applicants to B&I

 To provide equity to student applicants

 To provide a common source of information to B&I

 In short – Decrease the likelihood of B&I frustration and show a united front in providing opportunities







When Do We Collaborate?

- · Recruitment Timeline
- Now December, 2023 Companies register with Virginia Works and let schools system(s) know how many apprentices they anticipate taking and in what occupational area(s)
- January 2024 (prior to Showcase) Companies
 participate in a 15-minute virtual presentation about
 what to expect at each point of the timeline.
- January 30, 2024 (snow date of Feb. 6, 2024), 5:30 7:30pm, Green Ridge Recreation Center (light refreshments to be served). Regional RA Sponsor Showcase sponsor videos will be posted to the RCPS CTE website
- By February 29, 2024 Sponsor companies conduct parent/student information meeting at their choice of dates/times. Students should apply to selected companies following information meeting(s)
- March 1, 2024 March 29, 2024 Sponsor companies conduct interviews of students



When Do We Collaborate?

- · Recruitment Timeline
- <u>Following March 29th deadline</u> Companies participate in a 15-minute virtual presentation about next steps.
- By April 12, 2024 Deadline for Sponsor companies to notify students/parents and schools of selection(s)
- By May 3, 2024 School counseling staffs work with student schedules to maximize time for student at their sponsor business. Planning should consider the company's needs. This check is also used to ensure selected students are on track to graduate.
- May 3, 2024 Registered Apprenticeship Signing Day event





Application
